VILLAGE OF JOHNSON
ORDINANCES
ADDED AUGUST 31 , 1972

In accord with 24 V.S.A. 1971-1976 and 24 V.S.A. 2291 the following ordinances are adopted by the Village of Trustees of the Village of Johnson to become effective sixty (60) days from the adoption hereof:

Chapter 3, Article 2 is amended to read:

Article 2. MOTOR VEHICLES

Section 1. Speed limits.

- A. Except as limited below, no person may operate a motor wehicle of Village highways, not including state highways, at a rate of speed exceeding thirty (30) mile pershour.
- B. No person may operate a motor vehicle on the following highways at a rate of speed exceeding twenty (20) miles per hour.
 - 1. School Street
 - 2. Town Highway No. 58
- C. No persons may operate a motor vehicle on the follwoing highways at a rate of speed exceeding twenty-five miles (25) per hour.
 - 1. Railroad Street
 - 2. Rearl Street
- D. No person may operate a motor vehicle in excess of the posted speed limits in designated school zones as established by the trustees.

Section 2. Parking

- A. No person may park an automobile at any time in or on the following designated areas:
 - 1. Easterly side of Railroad Street from the northerly side of the bridge over the Lamoille River to a point that is two-hundred sixteen (216') feet from the intersection of the travelled portion of the easterly side of the Railroad Street with the southerly side of the travelled portion of State Highway No. 15.

- 2. Westerly said of Railroad Street from the intersection of the travelled portion of the westerly side of Railroad Street with the southerly side of the travelled portion of the State Highway No 15.
- 3. Westerly side of Pearl Street from the intersection of Pearl Street and School Street.
- 4. Easterly side of Stearns Street from State Highway No. 15 to the intersection with State Highway No. 100C and Johnson State Aid Highway No. 3.
- 5. Within the outside boundaries of any marked cross-walk.
- 6. Between any corner and a sign reading "No Parking Here to Corner", as established by the Trustees.
- 7. All Sidewalks.
- 8. In or within six feet of a driveway serving a fire station.
- 9. In any driveway.
- 10. On any bridge.
- 11. Within six feet of a fire hydrant.
- B. No person may park a motor vehicle in the following designated places at the following designated times:
 - 1. Any municipal parking lot between the hours of 2:00 A.M. and 6:00 A.M.
 - 2. All village highways between the hours of 12:00 A.M. and 6:00 A.M. during a period beginning 12:00 A.M. December 1 and ending 12:00 A.M. April 1.

Section 3. Stopping.

- A. All motor vehicles shall be brought to a complete stop at the following points when proceeding from one street to another within the Village of Johnson.
- 1. When entering School Street, State Aid Highway No. 3, from the College Campus on Town Highway No. 58.

- 2. When entering Pearl Street, State Aid Highway No. 1 from School Street, State Aid Highway No. 3.
- 3. When entering Vermont Route No. 100C from School Street, State Aid Highway No. 3.
- 4. When entering Vermont Route No. 15 from Collins Hill Road, Town Highway No. 51.
- 5. When entering Vermont Route No. 15 from Pearl Street, State and Highway No. 1.
- 6. When entering Vermont Routh No. 15 from Railroad Street, State Aid Highway No. 2.
- 7. When Entering Railroad Street, State Aid Highway No. 2 from River Street East, Town Highway No. 44
- 8. When entering Railroad Street, State Aid Highway No. 2 from River Street West, Town Highway No. 60.
- 9. When entering Railroad Street, State Aid Highway No. 2 from French Hill, Town Highway No. 5. fro
- 10. When entering Vermont Route No. 15 from Town Highway No. 37, running northerly from Vermont Route No. 15 westerly of Gihon River.
- 11. When entering Vermont Route No. 15 from Town Highway No. 63, running to the Catholic Church.
- 12. When entering Rearl Street, State Aid Highway No. 1, from Town Highway, No. 64.
- 13.] When entering ReartoStreet, State Highway No. 1, from Town Highway No. 55.
- 14. When entering Railroad Street, State Aid Highway No. 2, from Town Highway No. 59 running to Lamoille View Cemetery.
- 15. When entering Railroad Street, State Aid Highway No. 2, from Town Highway No. 61, Clark Street.

Section 4. Miscellaneous restrictions

- A. No person max operate an automobile with a cut out open.
- B. No person may drive a motoryvehicle over a fire hose.

- C. No person may park his automobile such that the vehicle is to the right of the edge of the highway as the vehicle would travel forward.
- D. No person may stop a motor vehicle on a bridge.
- E. No person may operate a motor vehicle at any intersection such that he executes a "U" turn.
- F. No person may double park a motor vehicle.
- G. No person may park so as to obstruct the normal flow of traffic.

Section 5. Penalties.

A person shall be fined for any violation of the requirements of this article in accord with state law establishing a general penalty.
